DISCIPLINARY RECORD REQUEST

IN ACCORDANCE WITH THE GEORGIA LAW BELOW, PARENTS MAKING APPLICATION TO FIRST BAPTIST CHRISTIAN SCHOOL SHOULD FORWARD THIS FORM TO THEIR CHILD'S CURRENT SCHOOL.

GEORGIA LAW - A new Georgia law (O.C.G.A. 20-2-670) provides "...a transferring student may be admitted on a conditional basis if he or she and his or her parent or legal guardian executes a document providing the name and address of the school last attended and authorizing the release of all academic and disciplinary records to the school administration..." and "shall also disclose on the same document as the release whether the child has ever been adjudicated guilty of the commission of a designated felony act as defined in Code Section 15-11-37 and, if so, the date of such adjudication, the offense committed, the jurisdiction in which such adjudication was made, and the sentence imposed.... The student or his or her parent or legal guardian shall also disclose on the document whether the student is currently serving a suspension or expulsion from another school, the reason for such discipline, and the term of such discipline. If a student so conditionally admitted is found to be ineligible for enrollment pursuant to the provisions of Code Section 20-2-752, or is subsequently found to be so ineligible, he or she shall be dismissed for enrollment until such time as he or she becomes so eligible."

AUTHORIZATION OF RELEASE OF EDUCATIONAL AND DISCIPLINARY RECORDS
